TERMS & CONDITIONS

The membership programme (‘the Membership’) is the provision of products and services at a fixed term and fixed fee to natural persons by Canvas Belong Limited (the ‘Company’), which is a company incorporated in Hong Kong.

I hereby apply for the Membership, and the resultant privileges thereof, and acknowledge and agree specifically without limitation, to the following:

I understand my application is subject to the review, approval and acceptance by the Company within 7 working days from the application date and receipt of the joining fee whichever is later. The Company reserves the sole right to accept or reject my application without assigning any reason whatsoever.

Acceptance will be notified through email with a membership number and date of commencement being provided. Date of commencement shall be 7 working days from the application date and receipt of the joining fee whichever is later and shall not be earlier than 1 March 2019. The Membership period shall be valid for 5 years (e.g. memberships with a commencement date of 2 March 2019 shall terminate on 1 March 2024). For the avoidance of doubt, membership privileges shall only be valid and available during the membership period.

I understand that the Company shall notify me at least one month before the 2nd membership payment of US\$9,000 is due. For the avoidance of doubt, the 2nd membership payment shall be due 2 years from the commencement date (e.g. the 2nd payment for memberships that commences on 2 March 2019 shall be 1 March 2021). If the Company does not receive such payment by the due date, my Membership will be terminated automatically with no further notice.

I am entitled to terminate my Membership and seek a full refund within the Cooling Period. The Cooling Period is defined as 14 working days from the commencement date. The request for a termination must be via email and must be received by the Company within the Cooling Period. The Company shall acknowledge such receipt and revert via email the effective termination date. For the avoidance of doubt, no products and services will be provided after the termination date even if any prior reservations or arrangements have been made. A full refund of the same amount that was paid to the Company at the time of application will be made by the Company by cheque within fourteen working days from the termination date. After the Cooling Period, there shall be no disputes whatsoever with regards to all payments made towards the Company and under no circumstances will I be permitted to terminate the Membership. I hereby waive the right to seek any refund, wholly or partially, of payments made to the Company after the Cooling Period.

I acknowledge that lifestyle offerings are all products and services which are provided by third-party companies which may not be related to the Company. Should I choose (at application) to include lifestyle offerings in my Membership, I am entitled to redeem up to five selections from the list provided in the booklet given by the Company at the time of my Membership application. Should any of the lifestyle offerings become unavailable (at the time of redemption selection), a similar alternative will be provided and a total of fifteen lifestyle offering selections shall be maintained at any given time. The Company shall provide me with the vouchers (issued directly from third party companies) within 7 working days after my redemption selection has been made. The Company will have fully discharged its obligations to me for each redemption upon provision of the relevant voucher. The Company shall not be liable should the products or services become unavailable after the relevant voucher(s) has been provided. I hereby waived the right to hold the Company liable for such special performances.

I am not bankrupt and no bankruptcy or analogous legal proceedings have been commenced against me in any country.
